

PRIVACY POLICY

1. Scope of the Privacy Policy

The Practice takes the privacy of Users of Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's website very seriously. Please read the following to learn more about Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's privacy policy.

- 1.1. This policy relates to how The Practice uses, stores and collects personal information collected from Users of Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's website.
- 1.2. Personal information is information about the User that is personally identifiable like the user's name, surname, email address, and/or postal address and that is not otherwise publicly available.
- 1.3. This policy does not apply to the practices of companies that Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute does not own or control or with whom Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute is affiliated or contracted, or to people that The Practice does not employ or manage.
- 1.4. This Privacy Policy forms part of the **Terms and Conditions** of use for Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's website.

2. Use and Collection of the Information Collected

- 2.1. The Practice collects personal information when the User request to be contacted or to be provided with more information on the services Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's provide. The Practice may combine information about a specific User with information it obtains from business partners or other companies.
- 2.2. Once a user has registered on Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's website the User will no longer be anonymous to The Practice.
- 2.3. At the point of collection The Practice will provide the User with an "opt-out" mechanism that will provide the User the opportunity to indicate that he/she does not want The Practice to send the User any further communications.
- 2.4. The Practice uses information collected from Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's website, for the following general purposes: to fulfill User requests for products and services, provide User's with The Practice's news, improve The Practice's services, and to conduct research.
- 2.5. Although The Practice will undertake reasonable endeavours not to allow the use of personal information for other purposes, Dr Kershlin Naidu T/A The Endocrine and Diabetes Institute's cannot guarantee that personal information will not be used for other purposes.

3. Children

- 3.1. The Practice takes the privacy of children online very seriously. Children

under the age of 13 years should have a parent/guardian's consent before providing any personal information to The Practice. The practice will not

5. The user's ability to delete his/her information
